What is this product?

Term

80% of the Nominal Amount is due on 27 March 2024 and the remaining 20% on 27 March 2028 unless the product it automatically cancels under the conditions detailed in the section on “**How performance is determined**”.

Objectives

The objective of the product is to make an investment in a financial instrument linked to the behavior of (an) underlying asset(s) in order to obtain a return while assuming a risk of loss of capital. The amounts listed below refer to each Nominal Amount you invest. The Calculation Agent will determine the corresponding amounts.

Underlying(s)

The return on this product is determined by reference to Banco Bilbao Vizcaya (Bloomberg-BBVA SM Equity) and Repsol SA (Bloomberg-REP SM Equity).

How the performance is determined

- On 27 March 2024, you will receive a coupon of 5% on 80% of the Nominal Amount for the period between 27 March 2023 and 27 March 2024, calculated on ACT/365, and you will receive 80% of the Nominal Amount.
- For the remaining variable portion of the Nominal amount invested (20% of the Nominal Amount): On each observation date, if the closing price of the Worst Performing Underlying is greater than or equal to 85% of its initial level, you will receive on the corresponding settlement date a coupon of 5% of the variable portion of the Nominal Amount invested. If no coupons were earned on the prior observation periods, then you will receive a coupon of 5% for each prior period in which no coupon was earned. Otherwise, you will not receive any coupons.
- Additionally, on each Observation Date, if the price of the Worst Performing Underlying is greater than or equal to the initial level, you will recover the variable portion of the Nominal Amount invested and the product will be terminated. Otherwise, the product will continue to the next observation period.
- At maturity, if the product has not been terminated early: if the final level of the Worst Performing Underlying is strictly less than 50% of its Initial Level, then you will receive the variable portion of the Nominal Amount invested minus the proportional fall in the Worst Performing Underlying from its Initial Level. Otherwise, you will receive the full variable portion of the Nominal Amount without any loss of capital.

Intended retail investor

A product aimed basically at: to any customer, with an advanced level of knowledge or prior experience with the product or similar products, with the capacity to assume a 20% of losses, whose risk profile is a <<medium-low risk>>. Furthermore, the investment objectives of the target customers would be tied to an investment horizon in line with the maturity of the product and whose aim is to generate income from capital and capital growth, under a service consisting of execution only (except for retail customers), execution only with appropriateness test, independent advice, non-independent advice and discretionary portfolio management.

The risk indicator assumes you keep the product until 27 March 2028. You may not terminate the contract early, unless an agreement is reached with the institution to that effect under the terms of the contract.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7, which is a <<medium-low risk class>>. This classification takes into consideration two elements: 1) the market risk (the volatility risk of the underlying asset and the interest rate risk) - that rates the potential losses from future performance at a low risk level; and 2) the credit risk which estimates that poor market conditions are unlikely to impact the capacity of Banco de Sabadell, S.A. to pay you. In the application of the European directive 2014/59/EU, for the recovery and resolution of credit institutions and investment firms, the risk that the resolution authorities decide to redeem or convert the financial instruments subject to recapitalisation into other values, or transfer assets and/or business units of the issuer. How long should I hold it, and can I take my money out early?

Recommended holding period: 5 years

The recommended holding period is selected to correspond with the maturity date of the product. Please note that except in automatic early repayment cases, the product is not expected to be called prior to maturity, as it lacks liquidity. In any event, should the institution consent to the early call under the terms set forth in the contract, this would be done at market value and additionally with a cancellation cost that would never exceed 1% of the contracted nominal value.
