# TERMS AND CONDITIONS OF THE "DISNEYLAND® PARIS WITH MASTERCARD CARDS FROM BANC SABADELL" PROMOTION

### 1. ORGANISER AND PRODUCTS OR BRANDS SUBJECT TO THE PROMOTION

Banco de Sabadell, S.A. (hereinafter, the Bank) conducts a promotion aimed at natural persons, over 18 years old, residing in Spain, who are the holders of Mastercard cards (personal consumption through mobile payment) issued by the Bank (hereinafter, Mastercard cards). Participation in the promotion entails acceptance of these Terms and Conditions.

The promotion will be announced via email and on the promotional website <u>www.bancsabadell.com/sorteodisneylandparismastercard</u>, on Banco Sabadell social media, and on the Banco Sabadell corporate website: <u>https://www.bancsabadell.com/</u>.

#### 2. EXCLUSIONS

Company credit cards and VISA cards are excluded. The participation of employees of the Bank or affiliated companies, advertising agencies, or collaborating companies in this promotion is not allowed. Participation of relatives up to the second degree of any of the aforementioned is also not allowed.

#### 3. PROMOTIONAL PERIOD

The promotional period runs from 12:00 AM on 15/01/2024 until 11:59:59 PM on 01/02/2024, Spanish peninsula time (hereinafter, the "**promotional period**").

#### 4. PARTICIPATION AND PROCESS

The promotion is open to customers holders of the **Mastercard cards** who, during the promotional period, have made at least **5 purchases with mobile payment** (of any amount). After five or more purchases, the participant will get one entry.

"Purchase" is defined as any transaction made with the **Mastercard card** with mobile payment for the acquisition of a good or the payment for a service of consumption, expressly excluding the payment of financing transactions, even though such may be settled as a "purchase". Cancelled or returned transactions are excluded from the promotion. The **cardholder** must provide the Bank, if it requests it, with the supporting documentation that shows the transaction is a "purchase" as defined under this heading.

Participation in the promotion is free of charge, and is limited to a maximum of one (1) entry per person, identified by their National Identity Card/Foreigners' Identification Number and/or email address, regardless of mobile payment purchases made with **Mastercard cards** within the **promotional period**.

#### 5. **PRIZE**

- A weekend at Disneyland Paris for four people on February 23, 24, and 25, 2024. (Round-trip flights from Madrid or Barcelona included)

- Four tickets with fast-track pass for both Disneyland Paris parks, valid for 3 days.
- Gift cards for park restaurants and shops. (The value of the cards will be confirmed upon receipt of the prize)
- Priceless Experience: Ignite the magic of the Disney Dreams show and marvel as the park comes to life at night.

The Bank reserves the right to change the prize for another of equal or higher value. The gift will be subject to the particular conditions of Disneyland<sup>®</sup> Paris.

#### 6. DRAW AND PRIZE DELIVERY

The draw will take place on 5 February 2024.

All received entries that fully comply with these terms and conditions will qualify for one entry in the draw. Those who fail to meet the minimum required purchases to participate will not receive a legitimate entry for the draw.

After the promotion concludes, a file with the data of all qualifying participants will be generated, each assigned an individual identification code. This file will be submitted to a notary, specified in point 10 of these legal terms, to conduct a draw where **a single winner** of the "**prize**" in this promotion will be chosen.

The notary will randomly determine 1 winner and 20 alternates, who will be kept in reserve.

For the delivery of the prize, the winner must sign the **letter of acceptance**, where he/she authorises the companies listed under point 7 to access and process the personal data necessary for the management of flights and experiences included in the prize.

The **Mastercard cards** must be valid and operational and the cardholder must not be in default with the bank; these terms and conditions apply from the start of the promotion and, if applicable, until the prize is awarded.

### 8. TAXATION
