

“3 months free” Promotion T&C

Information document

- Promoters:** the promoters of the “3 months free” Promotion (hereafter the “Promotion”) are: Meridiano, S.A. Compañía Española de Seguros, Tax Code A-18006296 and registered office at Avd. Jean Claude Combaldieu, nº 5, 03008 Alicante (hereafter, “Meridiano”), and BanSabadell Seguros Generales, S.A. de Seguros y Reaseguros, Tax ID No. A-64194590 and registered office at c/ Isabel Colbrand, 22, 28050 Madrid (hereafter, “BSSG”) which underwrite the insurance on a 50% each co-insurance basis with Meridiano as the opening insurer.
- Promotional period:** from 14 October 2024 to 31 December 2024 (both inclusive).
- Promoted product:** Funeral Protection¹ insurance in the regular premium option taken out through BanSabadell Mediación, Operador de Banca-Seguros Vinculado del Grupo Banco Sabadell, S.A.² (hereafter, “BSM”)
- Entrants:** Banco de Sabadell, S.A., customers who are individuals of legal age, resident in Spain and have applied to take out the insurance product included in the promotion between 14 October 2024 and 31 December 2024 with a policy effect date no later than 31 December 2024 are eligible to enter the “Promotion” (hereafter, “Entrant(s)”).
- Promotion:** 3 free monthly payments of the total annual premium* of the Funeral Protection insurance taken out only during the first year of the insurance policy.
- Promotion requirements:**
 - The Entrant has to take out a Funeral Protection insurance policy in the regular premium option during the promotional period through BSM.
 - They must maintain it for at least one year in good standing.
 - The amount of the monthly premium must be at least €10.
 - The Entrant may choose the form of payment which best suits their needs, preferences and interests:
 - Monthly payment** method: you get 3 free monthly payments and do not pay the bills* for months 4, 5 and 6.
 - Quarterly payment** method: you get 3 free monthly payments in the bill* for the second quarter in month 4.
 - Half-yearly payment** method: you get 3 free monthly payments in the half-yearly bill* in month 1.
 - Annual payment** method: you get 3 free monthly payments in the annual bill* in month 1.
