TERMS AND CONDITIONS OF THE "JULY APPLE WATCH"

1. ORGANISER AND PRODUCTS OR BRANDS SUBJECT TO THE PROMOTION

Banco de Sabadell, S.A., Avenida Óscar Esplá, 37, 03007, Alicante, registered in the Mercantile Registry of Alicante, volume 4070, folio 1, sheet A-156980, Tax ID No. A08000143. A credit institution subject to the supervision of the Bank of Spain and registered in the Special Administrative Register under number 0081 (hereinafter, the Bank) is running a promotion aimed at natural persons, over 18 years of age, residing in Spain, who are listed as holders of Mastercard Debit cards issued by the Bank (hereinafter, **Mastercard cards**) or who contract and use them within the **promotional period** indicated in section 3 herein. 2. GEOGRAPHICAL SCOPE OF THE PROMOTION

The promotion covers the entire Spanish territory.

3. DURATION OF THE PROMOTION

The promotion will run from 00:00 on 01/07/2024 until 23:59:59 pm on 31/07/2024, Spanish mainland time (hereinafter, the **"promotional period"**).

4. LEGITIMATION TO PARTICIPATE

All natural persons, over 18 years of age, who are legal residents in Spain, and who are either holders of **Banco Sabadell Mastercard debit card**, or contract it during the **promotional period** and, within the same period, add it to a mobile payment platform (Google Pay, Apple Pay or Samsung Pay) incorporating it into the digital wallet of their telephone terminals (hereinafter, "**register the Card**") and use it to make at least one purchase in a physical store may participate in the promotion.

In all cases, it is of utmost importance to have received the promotion communication from Sabadell.
