

## Terms and conditions of the promotion aimed at individual customers “300 euros for having your salary paid directly into your account and for having Bizum at Banco Sabadell”

1. Banco de Sabadell, S.A. (hereinafter, the Bank) is running a special promotion aimed at natural persons resident in Spain and customers of the Sabadell Online Account or the Sabadell Account, for personal use.

Based on this promotion they can can:

- receive 300 euros<sup>1</sup> for a new direct deposit of their salary for a minimum amount of 1,000 euros in the Sabadell Online Account or in the Sabadell Account,
- and have Bizum linked with a Sabadell Online Account or Sabadell Account at Banco Sabadell. All in accordance with the terms and conditions of this promotion.

Participation in the promotion entails acceptance of these terms and conditions.

2. This promotion is open to Sabadell Online Account holders who have received a communication from the Bank by email informing them of this promotion and Sabadell Account customers who have received a communication from the Bank informing them of the promotion or who take part in it by visiting one of the Bank's branches.

3. Validity of the promotion: **1 July to 30 September 2024** inclusive.

#### 4. Terms and conditions of the promotion:

- The incentive consists of the payment of 300 euros<sup>1</sup> gross (deposit in account of 243 euros) to holders who deposit a new salary for a minimum amount of 1,000 euros in a Sabadell Online Account or Sabadell Account during the promotion validity period and who also have Bizum linked to a Banco Sabadell account.
- The salary shall be considered as having been paid directly into the Sabadell Online Account or the Sabadell Account from the moment the salary payment is received, always on the same basis.

For the purposes of meeting the requirement, the following definitions are used:

- **Salary:** when transfers are received in the Sabadell Online Account or Sabadell Account issued in accordance with the code<sup>2</sup> established for payment of salaries in the banking regulations relating to the clearing of transfers. The amount of each payment must be at least one thousand (1,000) euros.

To be eligible for this promotion:

- the salary must be paid directly into the Sabadell Online Account or Sabadell Account for at least 12 months without interruption,
- the Bizum service must be continuously maintained for the same period of time as the salary (12 months).

The Bank is authorised to debit the amount of the incentive paid into the account if it is found that the requirements set out in these terms and conditions have not been met.



- The payment of the 300 euros<sup>1</sup> gross (243 euros paid into the account) will be made during the first ten days of December 2024.
  - Each account holder can only receive one incentive for this promotion, regardless of the number of direct debits they make or whether they hold more than one Sabadell Online Account or Sabadell Account.
  - The new direct payment of the salary in the Sabadell Online Account or Sabadell Account must be made within the term of the promotion. New direct salary payments into accounts of the Bank prior to the promotion period and that have been closed during said period, as well as transfers of direct debits from other accounts of the Banco Sabadell group, are excluded.
5. The Bank reserves the right to amend or cancel the promotion, as well as to change the date of the payment of the incentive, which will be duly reported, and to exclude from the payment any person it deems ineligible or who has acted in bad faith..
  6. The terms and conditions of this promotion are governed by and subject to the laws and courts of Spain.
  7. This promotion cannot be combined with any other Sabadell Online Account or Sabadell Account promotion related to direct deposit of salary.
  8. The terms and conditions of this offer are deposited and notarised before the notary public of the Notaries Association of Catalonia, Mr. Javier Micó Giner, whose offices are at calle de Narcís Giralt, no. 57, Sabadell.

**Notes:**

1. The net amount of the 300 euro payment for the direct deposit of the salary is 243 euros. In accordance with personal income tax regulations, this amount is considered as securities income from movable capital subject to withholding tax at the currently applicable rate of 19%.
2. In accordance with the exchange rules for SEPA transfers. The purpose codes are those that appear in a standard ISO/SALA/salary list.
